



Driveway/Approach Addition Requirements

- THE CITY OF GRIMES IS NOT RESPONSIBLE FOR ESTABLISHING PROPERTY LINES.
- AN APPROVED PERMIT IS REQUIRED FOR ALL DRIVEWAY ADDITIONS **IF** YOU ARE DOING WORK IN CITY RIGHT OF WAY OR INCREASING THE SIZE OF YOUR APPROACH
- A CONCRETE APPROACH IS REQUIRED TO BE 6" THICK
- AN INSPECTION IS REQUIRED PRIOR TO POURING A CONCRETE APPROACH
- SAND IS NOT ALLOWED FOR BASE, IT MUST BE COMPACTED DIRT OR ROCK IN THE CITY RIGHT OF WAY
- AN EXPANSION JOINT MUST BE INSTALLED AT THE STREET AND THE SIDEWALK.
- YOU DO NOT NEED A PERMIT IF ALL THE WORK IS ON PRIVATE PROPERTY
- THE MAXIMUM WIDTH OF A DRIVEWAY IN AN "R" DISTRICT IS 24'
- THE MAXIMUM WIDTH AT THE CURB OPENING IS 34'
- 3-5 FOOT FLARES REQUIRED PER SIDE OF APPROACH
- THE DRIVEWAY AND CURB OPENING PROPORTION RATIO HAS TO BE MET. YOU CANNOT INCREASE ONE WITHOUT INCREASING THE OTHER. EXAMPLES ARE ON THE BACK OF THIS SHEET.
- THE PERMIT FEE FOR INCREASING DRIVEWAYS/APPROACHES IN CITY RIGHT OF WAY IS \$30

Exception – the driveway may be extended on the private side by 2 ft on one side, for a maximum width of 26 ft at the sidewalk. **** NEW ****

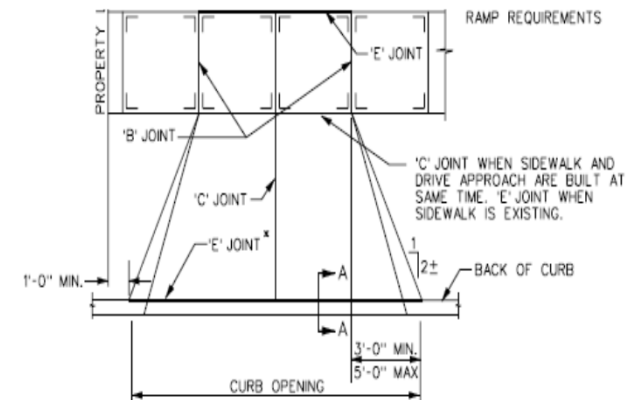

10'-0" MIN., 24'-0" MAX. (LOCAL/COLLECTOR):

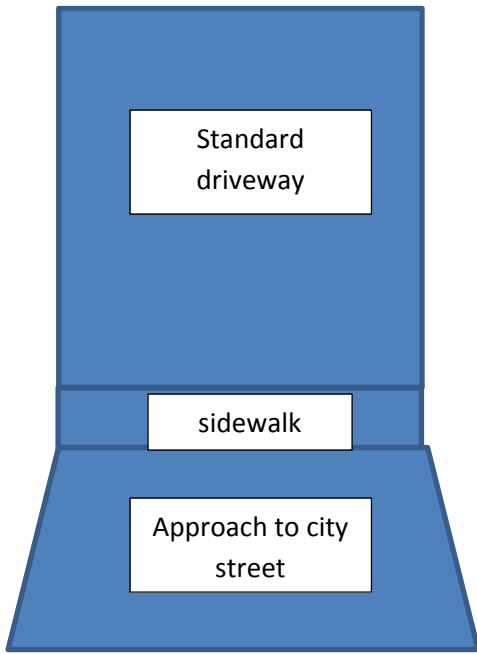

Standard Approach:

Max at top: 24 ft

Max at street: 34 ft

Minimum flare at street: 3 ft

Maximum flare at street: 5 ft
