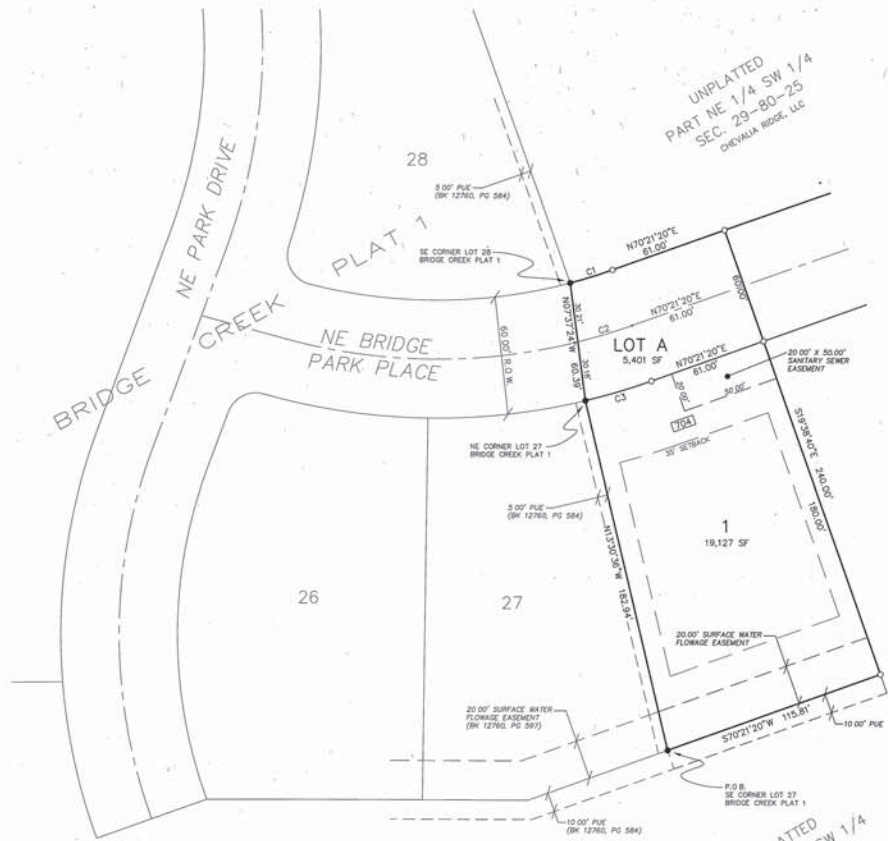

**LEGAL DESCRIPTION**  
Part of the Northeast Quarter of the Southwest Quarter of Section 29, Township 80 North, Range 25 West of the 5th P.M., now included in and forming a part of the City of Grimes, Polk County, Iowa, and being more particularly described as follows:  
Beginning at the Southwest Corner of Lot 27 in Bridge Creek Plat 1, an Official Plat, now included in and forming a part of the City of Grimes, Polk County, Iowa, thence North 13(degrees) 30(minutes) 36(seconds) West, 182.04 feet along the East line of said Bridge Creek Plat 1; thence North 07°37'24" West, 60.39 feet along the East line of said Bridge Creek Plat 1; thence northeasterly 22.71 feet along the arc of a curve concave northerly and having a radius of 270.00 feet, a central angle of 04°49'11", and a 22.71 feet long chord that bears North 72°45'56" East; thence North 70°21'20" East, 61.00 feet; thence South 19°38'40" East, 240.00 feet; thence South 70°21'20" West, 115.81 feet to the point of beginning.  
Containing 24,528 square feet (0.56 acres).
